

MINUTES OF THE ROYAL SOLENT YACHT CLUB ANNUAL GENERAL MEETING HELD ON SATURDAY 12TH APRIL 2025 AT 1100 HOURS

Eighty-six members attended the Annual General Meeting (AGM), including four Flag Officers and five General Committee members.

1. Apologies

Apologies were received in advance from 45 members, including the Hon. Treasurer, Rob Quain, and GC members Peter Crowhurst and Richard Pierrepont.

2. Approval of 2024 AGM Minutes – The Commodore

The draft minutes of last year's AGM on 13th April 2024 were reviewed in the April 2024 General Committee meeting and circulated to members via email or post on 21st March 2025. To date no amendments have been requested.

Proposed by Brian Crawford, seconded by James Day and approved unanimously as a true record in 28 votes cast in advance and by a show of hands.

3. To Receive and Adopt the Report of the General Committee for the Year Ending 2024 – The Commodore.

The Commodore welcomed everyone and stated that the meeting would follow the agenda in the Calling Notice and that there would be an opportunity for any questions from the floor at the end of the meeting, with no questions having been received in advance of the AGM. The Commodore highlighted the key points from the 2024 Report of the General Committee:

“It was a progressive year and there was some challenging weather again, but everyone coped extremely well. Price rises continue at a seemingly never-ending pace, but the Club is doing everything it can to avoid passing them all on to members and to reduce its costs as much as possible. On the sailing side, our three main regattas all went extremely well and received very positive feedback from the competitors. The RSYC Contessa Regatta has Jeremy Rogers Ltd and Louis Jadot as its main sponsors. The Taittinger RSYC Regatta is of course sponsored by Champagne Taittinger, alongside River Yar Boatyard, Wight Marine and the Edelweiss & Gurgl Hotel. Both events are also supported with a supply of fresh berries from Hall Hunter. Folkboat Week is sponsored by Lymington Yacht Haven. A highlight of this year's event was the presentation of the Nordic Folkboat Gold Cup to the Royal Solent. Congratulations to member Ed Donald and his fellow crew members for being the first to race a British boat to victory in the Nordic Folkboat Gold Cup Regatta 2024.

David Porter retired as a volunteer RIB driver after more than 20 years and he was awarded the Gold Lace Bowl in recognition for his services. David continues to run the very successful Cruising Group which is open to all members.

Ashore, ever wider and more imaginative events were on offer last year to appeal to members' diverse interests. Ladies' Lunches reached record numbers – having an interesting speaker appears to be key.

The Club was proud to host the RNLi's 250th Anniversary Gala Ball for 150 guests last May. Our Summer Party for another 150 guests was also a great success with live music and flaming bagpipes from the Wight Hot Pipes who are also booked for this year's New Year's Eve party. The Club hosted another anniversary event in December to mark 30 years since the automation of the Needles Lighthouse, featuring old film footage collated by Bol Minchin.

The boat sheds renovation project is ongoing, with the recent completion of the southeast corner store and the remaining sheds scheduled to be refurbished by the autumn to provide open facilities for winter boat storage and summer events. The situation with next door Bank House was a complex legal matter left to us by history. I am pleased that an agreement was reached with the previous owners and we now have new neighbours who are delightful, Andrew & Jacqueline Greening, who have now joined the Club. My thanks to Tom Symes and Rudi Fortson for their time and expertise in helping to secure a mutually beneficial agreement.

The latest edition of the RSYC magazine is once again a great read – our thanks go to Teresa Fox, Claire and the rest of the team for another professional magazine that shows the world what we do and how we do it.

Our thanks as always go to our amazing staff whose hard work and welcoming approach make this Club a jewel on the south coast which sets the gold standard for other clubs. Our membership closed at the end of the year at 1,138 - its highest level to date. We do ask that our members propose their friends and family and then accompany them to the Club to help them acclimatise and enjoy their experience. Thank you to all those members who have introduced new members to the Club – it makes all the difference and please keep doing it.

In conclusion, we all know that there are challenging times ahead, particularly on the costs front, but we are better placed than most to handle these and, most importantly, we have the team able to manage them. Thank you for your continued support and for listening. Unfortunately, our Honorary Treasurer Rob can't be with us today for personal reasons, but John Poyner will be stepping in to read the Financial Report. Any financial questions at the end of the meeting will be noted and responded to as soon as possible after the meeting.

The 2024 Report of the General Committee was proposed by Kathy Collinson, seconded by Dick Dawson and approved unanimously in 28 votes cast in advance and by a show of hands.

4. To Receive and Adopt the Financial Report for the Year Ending 2024 – Hon. Treasurer (delivered by Rear Commodore House, John Poyner)

“Good morning, everyone. I'll try to cover the financials briefly before everyone dozes off. For those who attended last year's AGM, I ended my presentation on a rather optimistic and confident note. For the first 3 quarters it proved to be correct. We were, however, faced with some high costs for essential works on the clubhouse late in the year, which took us into a £16,256 operational deficit.

The Royal Solent's finances do, however, continue to be sound with sensible cash reserves for capital improvements and other projects as I will mention later. You will see from the annual financial statement our income derives from two main sources; subscriptions from members which is predictable and most arrive in one go in January, and trading income from the bar & catering which is less predictable and skewed towards the late spring and summer. Other income comes from regattas, moorings, merchandise, car parking etc.

After the first two weeks of January, for the normal clubhouse spring clean and staff holidays, the Club was fully open all year. Our annual turnover was lower than in 2023, by just over £5,000, at £947,451. However, unlike in 2023 when I commented on a reduction, our costs in 2024 were higher and our gross profit from trading lower as a result by some £18,198.

I mentioned essential works to the clubhouse earlier. This included vital work to the outside, to the balcony drainage and to the emergency fire escape staircase carried out in the later part of 2024. If we had not done this work, the damage would have been far greater and the costs to resolve, significantly higher. The decision was made to do it now rather than wait, in the knowledge it could have a big impact on our overall financial result for 2024. And so it proved to be.

We were also not immune to higher energy and food prices as well as costs for boat and mooring maintenance all going up. These all fed through to our bottom line. Taking into account all our cost of sales and administrative expenses, the Club's end of year audited position declined from a deficit of £8,267 in 2023 to an operational deficit of the £16,256, as I mentioned at the start.

I should point out that the Taittinger RSYC Regatta 2024 was a great success on the water, although income from Sailing overall was down by £13,149, partly due to the filming sponsorship we benefited from in 2023 not repeated

in 2024. In addition, the Club sold the old Solent RIB last financial year which improved our bottom line by almost £10,000 then.

Our staff are our key resource and their excellent service is one we are rightly proud of. However, we must attract and retain when local demand for bar and catering staff is high and financial incentives are clear to see. This we did by looking after our staff with affordable pay rises and generous bonuses once again. At this point I would like to thank members on behalf of the staff for their generosity contributing to the Goodwill Fund which operates its own bank account and is not part of the Club's funds.

Subscriptions held up very well and we ended 2024 with more members than we started with and income increasing by £22,413 despite just a modest increase in subscription rates. This rate was significantly less than many other clubs on the Solent.

Our costs as a yacht club are driven by providing facilities for members in the clubhouse, plus racing and cruising services on the water. No surprise there. Salaries and maintenance of the Club's assets make up the bulk of the annual costs and it is a careful balance we must make to ensure we deliver quality at a cost we can afford.

In a normal year we aim to break even or make a little surplus to put towards reserves for future projects, although this is increasingly more difficult to achieve. We have budgeted very conservatively this year and I am optimistic that with careful control of costs, this will be achieved.

Onto the audit. Although not legally required, we have once again had our accounts audited externally by Harrison Black who know our club records well. I'm pleased to report once again only a very few observations were noted. I will be proposing Harrison Black as our auditors for 2025 shortly.

Now, on to capital projects. In 2023 the main project was the refurbishment of the East Shed as the new Boatmen's Workshop. Last year, apart from the clubhouse works mentioned above, we also refurbished the corner part of the sheds as the new Club storage facility, much needed for our outside furniture, racing equipment and space for Solent RIB.

The main projects for 2025 are as follows;

1. New Club website as the current one is no longer supported and lacks some modern functionality we would like. Already underway and planned to go live later this year.
2. Refurbishment of the remainder of the South Shed, with a generous offer of fund raising by the Y Class, and we hope to get this project to restore the sheds underway in the Autumn this year.

2025 may be a difficult year financially. We are all feeling the pinch. The Club is of course affected by the Chancellor's Budget where the minimum wage and NI increases will have a direct impact. Business Rates relief has also been cut from 75% to 40% this year.

However, the Royal Solent is a great club and I remain optimistic and confident that 2025 will be a sound year financially as members continue to use the Club's facilities both on the water and in the clubhouse.

Club social events are well supported and I'm sure this will continue throughout the year with a full programme from the RCH and delivered by our excellent staff. I for one look forward to another successful and enjoyable Taittinger RSYC Regatta this summer.

Finally, I'd like to thank a couple of people who have helped me this year. Janet, our Finance Administrator, has provided me with all the information I have asked for in a timely and efficient way. And also, in anticipation of support this year, past Commodore, Anne Kyle, now one of our Guardians, who has always been a good sounding board with a depth of knowledge on all things relating to the Club's finances."

The 2024 Financial Report was proposed by Mark Hall, seconded by Alan Hans Hamilton and approved unanimously in 28 votes cast in advance and by a show of hands.

5. Reappointment of Harrison Black as Auditors – Hon. Treasurer (delivered by Rear Commodore House, John Poyner)

The reappointment was proposed by Anne Kyle, seconded by Richard Leonard and approved unanimously in 28 votes cast in advance and by a show of hands.

6. Election of Flag Officers – The Commodore

Election of John Poyner as Commodore. Proposed by Martyn Collinson and seconded by Nick Bradley. Elected by a majority in 28 votes cast in advance and by a show of hands.

The outgoing Commodore congratulated the incoming Commodore and presented him with the Royal Solent Yacht Club Commodore's burgee, tie pin and lapel pin.

Election of Rudi Fortson as Vice Commodore. Proposed by Martyn Collinson and seconded by Nick Bradley. Elected by a majority in 28 votes cast in advance and by a show of hands.

The outgoing Commodore congratulated the incoming Vice Commodore and presented him with the Royal Solent Yacht Club Vice Commodore's burgee.

Election of Susie Breare as Rear Commodore House. Proposed by Martyn Collinson, and seconded by John Poyner. Elected by a majority in 28 votes cast in advance and by a show of hands.

The outgoing Commodore congratulated the incoming Rear Commodore House and presented her with the Royal Solent Yacht Club Rear Commodore's burgee.
