## **REPORT OF THE GENERAL COMMITTEE 2024**

Commodore, Martyn Collinson

We enjoyed a progressive year in 2024, although the weather remained almost as challenging and unpredictable as the year before. Our sailing team, volunteer members and staff all managed the varying conditions admirably and the many races, rallies, regattas and onshore social events that we put on during the year were a great success.

Prices continued their seemingly never-ending rise causing a slowdown in turnover towards the year end. This, together with some unexpected essential maintenance work, resulted in a small deficit in our day-to-day operations for the year and against budget. This essential work consisted of significant repairs to the Members' Balcony and to the external staircase from our main balcony, plus replacing part of the wooden door canopy and fascia boards on the north side of the clubhouse due to rot. To have delayed these repairs would have only resulted in even greater costs going forward.

### **Sailing**

In June, we hosted our second RSYC Contessa Regatta with lead sponsorship from Jeremy Rogers Ltd and Louis Jadot, plus supporting sponsorship from Hall Hunter. The weather was fairly kind and twenty-seven Contessas returned to race at the RSYC. As one contestant wrote "What a fabulous weekend that was - with all the highs and lows that yacht racing brings. The RSYC Team is just brilliant". The event is being held a little earlier this year, from 16<sup>th</sup> to 18<sup>th</sup> May 2025.

The weather was more favourable for our Taittinger RSYC Regatta in July and we had one of the most successful weekends in the 16 year history of this event. Our thanks go to Katie Davies (Regatta Chair), Nick Bradley (Rear Commodore Sailing), Jeremy Willcock (CRO) and the volunteers who gave up their time to provide their support and expertise alongside our hard working Staff.

The sponsorship of Champagne Taittinger, Wight Marine and River Yar Boatyard gives us a top level prestigious status and we are very grateful. Our thanks also go to supporting sponsors the Edelweiss & Gurgl Hotel, Yarmouth Harbour, AQL and Hall Hunter and key supporters John Doerr and Peter Kingston (Protest Committee), Simon van de Byl (Senior Race Officer), as well as John Caulcutt and the YOD Class for the famous Towers Party.

The 59<sup>th</sup> Folkboat Week at the RSYC in August was also blessed with better weather than last year and some good sailing was enjoyed by 39 Folkboats and their crews. Our thanks go to David & Teresa Fox for making it such a success yet again and to the Lymington Yacht Haven for their sponsorship. The highlight of the week was the presentation of the Nordic Folkboat Gold Cup to the Club and our congratulations go to RSYC member Ed Donald and fellow crew members John Wulff (helm) and Cameron Tweedle who sailed Folkboat GBR808 to victory flying our Club burgee. This is the first occasion in history that the Gold Cup has been won by a British team in a British boat.

Also in August, sister/brother duo Claudia and Henry Olmi were instructors during Laser Training, which was well attended and enjoyed by many intermediate sailors. Dinghy Week, sponsored by Harwoods Chandlery and The Delphie Lakeman Trust, had varied conditions and it was impressive to see sailors launching in 20 knots of breeze, determined to complete their races.

An unseasonably blustery Sunset Series from 12<sup>th</sup> to 15<sup>th</sup> August was well supported by all classes with 34 boats participating and 12 boats participated during October, November and December in this year's Winter Series, sponsored by Wight Marine and River Yar Boatyard.

At the Helpers' Drinks held in the autumn, Flag Officers and sailors said a heartfelt thanks to David Porter for over twenty years of volunteering as RIB driver on Wednesdays, Saturdays and Sundays. David was also awarded the Gold Lace Bowl at the Laying Up Dinner for his many years of outstanding voluntary service to the Club.

### **Cruising**

Though retiring from his voluntary role as RIB driver, David Porter is still leading the successful Cruising Group in 2025. Lunchtime excursions include yacht and sailing clubs throughout the Solent. The Newtown Barbeque was held this year at the Oyster Bed Gardens and our thanks go to members Camilla and Jonathan Read for allowing us to use their little bit of Eden. While all parties are welcome to join the member boats going on these outings, some venues can still be attended by car as well.

## **Club Events**

Off the water, our House Committee and Staff offered the membership the usual wide and extensive programme of events covering all the many interests of our members. The recently revived Ladies' Lunches reached record numbers, film nights were well attended and the First Wednesday Talks had their usual range of talented speakers, and our thanks go to Kevin Shaw for his extraordinary ability to keep finding new speakers.

Highlights of the year included the RNLI 250<sup>th</sup> Anniversary Gala Ball in May, the Summer Party in August and the December lunch celebrating the 30<sup>th</sup> anniversary of the automation of the Needles Lighthouse at which attendees enjoyed a short film created by Bol Minchin from historic footage provided by Dave Kennett.

## **Boat Sheds**

Over the last three years the Club has been carrying out a major programme to renovate the boatsheds on our east and southern boundaries. During 2023 the east shed, which was in better condition than the south sheds, was renovated and the Boatmen's workshop moved to this new location. During the latter part of last year, the focus moved to the south east corner and the creation of an enclosed storage area for all the Club's outside furniture, plus gardening and sailing equipment. Our thanks must go to Rear Commodore House, John Poyner, for his time and expertise in making sure this project was completed on time and within budget. It is intended to renovate the remaining sheds during the summer to provide a suitable, sound structure for the storage of boats in the winter and a covered area which can accommodate Club events in the summer.

## **Bank House**

It may not be common knowledge that the L shaped grass strip to the south of our driveway and to the west of our car park has always been the property of the adjacent Bank House. The Club has been permitted to use the grass strip for many years and the owners of Bank House have in turn had a right of way down our driveway to access their car park at the rear of their property. This situation came about due to a number of complex legal agreements (some of which date back to the second half of the last century), which required considered analysis and negotiations.

After a lengthy negotiation, lasting months, I am pleased to report that we have now signed a new agreement with the owners of Bank House. The details are as per the terms approved by your General Committee at its meeting on 29th November 2024, namely that the land is now under Club ownership, apart from the area of land to the south of our entrance from the roadside to just beyond the first tree. This area will be fenced off and used by Bank House as a parking space, subject to planning permission being obtained by them. Their right of way over our drive will remain through a limited number of barrier tags. Bank House has recently been sold on to Andrew and Jacqueline Greening who have recently become members and we look forward to having a good relationship with our new neighbours.

This complex situation could not have been resolved without the enormous amount of time and effort given to us by members Tom Symes & Rudi Fortson, to whom the Club owes a huge debt of gratitude. The Flag Officers feel this is a satisfactory conclusion for the Club to a very complicated historical issue.

## **2025 RSYC Magazine**

The latest edition of the Club's magazine is now available to pick up from around the clubhouse and our thanks go to its new editor, Teresa Fox and our Secretary, Claire, alongside Paul Bellchambers and Anthony Davies on the editing/proof reading team. It is a professional publication, widely read and shows our members, visitors and prospective members what we are about and how much we have to offer. Our thanks also go to our Membership Secretary, Jane, for ensuring the printing and production costs were once again fully funded by the advertising.

## **Reciprocal Clubs**

During the year, the Royal Vancouver Yacht Club and the Little Ship Club both joined our list of reciprocal clubs making it over 60 clubs that you can visit while at home or abroad.

## **Membership**

We increased the number of members during 2024 to another record level – 1,138 at the year end. This was helped by two Open Days being held again in May and August. Our thanks go to Lesley Tregear for helping to organise these. I can only repeat that the best way to increase our membership is for our members themselves to propose

people they know and then bring them into the Club during their first months. During the year, the GC granted Honorary membership to Ed Donald for his amazing achievement, referred to above, in bringing the Folkboat Gold Cup to the Royal Solent.

## **Staff**

Last year we saw quite a few changes in our core team of Staff. Most notably, our former House Manager Brooke left us for pastures new after an incredible 10 years at the Club and our Head Waitress Danielle stepped up to take on the role, which she has achieved admirably. We also welcomed a number of new full time staff – Jon as Second Chef, Will as Assistant Boatman and Hannah as Kitchen Porter as well as part-time staff to the House team – Lils, Mandy, Martha, Alfie and Monty. Plus, Stuart received a very deserved promotion to Bar Steward. Our thanks go, once again, to all our staff for their loyalty, the warmth they show to everyone who comes to the Club and their commitment to keeping the RSYC the envy of clubs on the South Coast. Every month we receive letters and emails from clubs, individuals and visiting groups full of praise for the high standard of service and professionalism they receive during their visits.

- Charles Stanley Discretionary Trophy: Originally an annual regatta trophy but repurposed as an award for commitment and dedication to the Club, be it on or off the water – Lesley Tregear

## **General Committee**

During the year, Tom Symes had to stand down from the GC for personal reasons and we are most grateful to him for the support he gave to Rear Commodore Sailing, Nick Bradley, in particular, and to the GC in general. The General Committee co-opted Sarah Turvill to fill his place until the April 2025 AGM.

## **The Future**

The Club will undoubtedly have some hurdles to jump in the coming years if costs continue to rise at their current pace. With an increase in our membership and numerous volunteers willing to give us their time and expertise, we will be in a strong position to face the future and continue our progress going forward.

Your Flag Officers and General Committee thank you for your support and will continue to do their very best to ensure we remain one of the best yacht clubs on the South Coast. The RYA have told us only 10% of Yacht Clubs have over 1,000 members and we ended last year on 1,139. This is due to your support, the hard work of our Staff, Committee members and member volunteers – the future is positive.

We look forward to another successful and enjoyable year.

## **FINANCIAL REPORT 2024**

The General Committee has pleasure in presenting the Financial Report and Accounts Summary to members for the year ended 31st December 2024. A full set of audited accounts is available via the Accounts Office.

The Club was closed for almost three weeks in January 2024 to allow our staff to take extended time off built up during the year as well as carry out essential maintenance and refurbishment of the clubhouse. You will have seen the new shiny banister on the staircase!

We thought 2024 would be a steady year and so it proved until the last quarter when unbudgeted, but essential, expenditure was required on the upkeep of our clubhouse. A budget for growth was agreed for 2024 with challenging targets for both the bar and catering, as well as growing the Club's membership.

You will see from the Summary of Results for 2024 that the Club made an overall deficit after depreciation of £56,072 which is significantly worse than the deficit of £8,268 in 2023. Once depreciation is removed, the Club made an operational deficit of £16,256. While this is not good, given our cash reserves it is sustainable in the short to medium term. As I mentioned earlier, considerable work was undertaken in the final few months to enhance our clubhouse as well as heading off much greater cost in the future had we not done this now. Along with the refurbished emergency staircase from the eastern balcony, rotten wood was replaced on the exterior, stonework patched up and works to resolve water ingress into the Hudleston Bar, urgently undertaken.

Bar and catering margins held up due to greater use of the Club by members and their guests, plus visitors, throughout the year. The overall trading surplus declined to £27,892 (2023: £47,456).

Overall Club turnover slightly declined by just over 0.5% to £947,451 (2023: £952,708) which was a steady result. However, our overheads increased by 13% reflecting higher wages and utility and maintenance costs.

Subscription income increased by £22,413 despite only a very modest 3.5% increase in annual subs, which shows that the Club is attracting new members, as well as sustaining our existing membership well.

We continue to look after our staff well with competitive pay and conditions against a backdrop of staff shortages in the wider hospitality sector. However, our bar & catering staff costs flat lined last year. This is partly down to some gaps in staffing during the year; we plan to return to full staffing this year.

Onto capital projects. Members will remember we rebuilt the new Boatmen's Workshop and last year the additional Club Store was completed to budget. In addition, the new emergency outside staircase project was financed using the Club's cash reserves and progress is being made on the new website, planned to go live later this year.

The Club continues to have sound financial reserves, however given the costs outlined above, the year end bank balance was down on December 2023 by some £40k at £151,180 (2023: £192,094), due mainly to the cost of capital projects undertaken during the year. The generosity of our members with donations throughout the year is most appreciated.

Our 2025 budget is more cautious and designed to break even after depreciation while maintaining a healthy cash flow situation. I am confident this can be achieved.

<p><b>20. Classes and Election of Members</b></p> <p><b>20.6</b> The General Committee shall have the power to admit any person as an Honorary Member or an Honorary Life Member, on such terms as it may think fit, but the total number of such Members shall not at any one time exceed five per cent of the total number of Full Members. The Secretary shall give to a person elected as an Honorary Member or Honorary Life Member written notice of his or her election together with a copy of these Rules and, upon such person indicating in writing his or her willingness to accept such membership, he or she shall become an Honorary Member or, as the case may be, Honorary Life Member of the Club.
