NOTICE OF RACE

1. ORGANISING AUTHORITY

1.1 The organising authority is the Royal Solent Yacht Club.

2. RULES

2.1 The races will be governed by the current World Sailing Racing Rules of Sailing 2017-2020 (RRS) including the prescriptions of the Royal Yachting Association, the Notice of Race and the Sailing Instructions and any relevant class rules.

2.2 RRS 35, 40, 60.1(b) and 63.1 are changed in the Sailing Instructions.3

recreation and will be mindful of the importance of it when sailing together with any guidance or procedures specified by the Royal Solent Yacht Club and the RYA to COVID-19. Please inspect the Royal Solent Yacht Club water-based risk assessment form which can be found on the response to COVID page on the website.

3. ELIGIBILITY

- 3.1 Boats shall not be deemed to be racing unless the owner or person in charge has completed and returned the attached entry form together with the required fee for this event to the RSYC Sailing Secretary.
- 3.2 Late entries may be accepted at the discretion of the Race Committee.
- 3.3 All competitors under the age of 18 on 3rd August 2020 must ensure that their entry form and parental consent form is signed by a parent or guardian.

4. FEES

- 4.1 There is an early bird entry fee of £40.00 for four days racing prior to 27th July. From the 27th July onwards entry for four days racing is £50.00 Daily entry is £20.00.

5. CLASSES

- 5.1 Classes will include:
 - Laser full rig and Radial
 - Laser 4.7
 - Pico (race sail)
- 5.2 Classes may be combined at the discretion of the Race Committee.
- 5.3 There must be at least three entries in order to run a class.

6. SCHEDULE

- 6.1 Briefing to all competitors and parents on “Zoom” on Sunday 2nd August.at 17:00
Invitation will be sent out by KJD
- 6.2 Registration will be on Monday 3rd August between 09.20am and 09:45 at the RSYC times staggered between 09.20 and 09:45, with a briefing for all sailors at 10am.
- 6.3 There will be two races run back to back each day, at the discretion of the Race Officers, additional races may be run. Competitors will need to check with the PRO
- 6.4 The scheduled time of the first warning signal will not be before 11.00am.

7. RACING AREA

- 7.1 Racing will be in the area the Western Solent and/or Bouldnor Bay.

8. PROTESTS

8.1 The Exoneration Penalty and the Advisory Hearing and RYA Arbitration of the RYA Rules Disputes Procedures will be available.

9. SCORING

9.1 The low point scoring system of RRS Appendix A will apply.

9.2 In each class 2 races are required to be completed to constitute a series.

10. SAILING INSTRUCTIONS

10.1 The Sailing Instructions will be available at RSYC or to download from www.royalsolent.org from 1st August 2020.

11. PRIZES

11.1 Trophies will be awarded to the overall winner in each class for in the regatta.

Also, trophies will be awarded to:

- Laser Regatta – Best Under 16 Laser Radial or 4.7
- Pico and – Best Junior (under 14)

11.2 The Prize Giving will take place on Thursday 6th August on the lawn of the RSYC.

12. RISK STATEMENT

12.1 Rule 4 of RRS states: “The responsibility for a boat’s decision to participate in a race or to continue to race is hers alone.” Sailing is by nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor or if a junior it’s parent or guardian agrees and acknowledges that;

(a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk while taking part in the event;

(b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;

(c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;

(d) The boat is in good order, equipped to sail in the event and they are fit to participate;

(e) The provision of a race management team, patrol boats and other officials and volunteers by the race organiser does not relieve them of their own responsibilities;

(f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;

(g) It is their responsibility to familiarise themselves with any risks specific to the venue or event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

13. INSPECTION:

13.1 The fact that race officials may carry out inspections of a boat does not reduce the responsibilities of each competitor to ensure compliance with the above.

14. INSURANCE

14.2 All boats are required to hold adequate insurance and in particular to hold insurance against third party claims including cover for racing in the sum of at least £3,000,000 (three million pounds sterling). By entering, entrants declare that such cover will be maintained in full force throughout the season and agree to allow the RSYC, at its discretion, to pass on their contact details to third party insurers in the event of a possible insurance claim.

15. BOAT HANDLING ABILITY

15.1 All competitors must be capable of launching and recovering their boats as sea conditions at the RSYC slipway can be demanding. This is a SAFETY MATTER and ALL COMPETITORS are solely responsible for this activity. Launching and recovery teams are at hand but cannot guarantee to be always available at busy times. Parents are required to assist with this SAFETY task.
