Prior to the start of the meeting, the Commodore asked GC members to stand to observe a minute's silence for members Ian Carruthers, Rod Hockin, Denis Cross and John Crowhurst, who had all sadly passed away since the last GC meeting.

**83/25 Approval of Minutes from 31<sup>st</sup> October 2025 Meeting** The minutes were approved as a true record.

## 85/25 Commodore's Update

Members' Drinks Discount. The Commodore advised that a policy decision regarding the members' discount on drink was needed in order to hit the proposed budget next year. It is proposed by the Officers to reduce the discount from 17.5% to 15%, which should generate additional annual income of £5-6k for the Club. The drinks discount was increased from 15% to 17.5% in July 2019. [All present agreed with this proposal and the Commodore advised that it would come into effect and be announced to the membership in January, with an emphasis on other costs having been kept down.](#)

Club Secretary's Hours. The Club Secretary wishes to reduce her hours from 5 days a week to 4 days on a trial basis from April, after the new website has gone live. All present were ok with this.

Charles Stanley Event. Having been based on the Island previously, investment management and financial planning firm, Charles Stanley, has sponsored a racing mark for some time. [To incentivise them to continue to do so, it has been suggested to invite them to run a one-off seminar at the Club for members. All present supported this.](#)

## 86/25 Financial Report by Hon. Treasurer

October Results. Catering turnover in October was very strong – way ahead of budget and last year. In spite of a weak September, the year-to-date figures are really impressive at a profit of £7.5k compared to a deficit of (£12k) last year and a budget of (£11k). Seasonal staff costs continued to be high in October, most likely due to continued holiday cover, and are way over budget for the year-to-date. The overall result for the year-to-date of £7.5k in the black is a really good result so bodes well for the end of year. In terms of cash, more has been spent this year than last, so it is lower but we are still in a strong position, plus the Y Class still owe the Club £25k for the South Sheds which we should receive next year.

2026 Budget. Two budget meetings have been held to attain the proposed Budget v2 for 2026, which has been circulated via email. The aim, as usual, is to break even operationally. The year end target income has grown by £30k year on year through the modest increase in subscription fees, plus increased bar targets and entry fees. The Hon. Treasurer considers the budgeted income not to be too bullish. In terms of expenditure, there is a bit more control. The salary total under 'Admin' takes into account the Club Secretary's reduced hours from April. The overall salary bill will increase next year due to the Government's increases in the minimum and living wages. The rateable value of the clubhouse has dropped from £42k to £30k following our challenge and, whilst the relief scheme is ending on 31<sup>st</sup> March, but the multiplier is decreasing from 49 to 38.2. In terms of sailing, there is a chunk set aside for moorings maintenance, including merging A trot into B trot and the new Crown Estate mooring charge of £100 per mooring. Hopefully, there are sufficient funds allocated to cover standard boat maintenance and there won't be any exceptional work required. If expenditure is in line with the proposed budget, this will achieve an operational surplus of £2.5k, which is essentially similar to this year. The Hon. Treasurer believes it to be a sound and fair budget. The staff are getting a fairly generous pay rise as they deserve it



(Addendum: 3% average pay rise in January against a current inflation rate of 3.5%). The Commodore commented that the big unknown is the subscription renewals in January, given the amount of doom and despondency in the news. There has been some degree of ball juggling to ensure that subscriptions do not increase too much and staff wages are in line with the increasing cost of living. Anne Kyle suggested that the budget could be finalised and approved in January once the renewals position is better known. As the proposed staff pay rises are from 1<sup>st</sup> January, the quarterly budget reviews will suffice. All present were happy with the proposed budget for 2026. The Hon. Treasurer advised that he didn't foresee any major project work in 2026, with the exception of the South Sheds roof at approximately £13k. It will be decided in the new year whether to proceed with this or not.

87/25 Vice Commodore's Report

The GC approved this application for membership.

Non-Members in Club Boats. The matter of non-members on Club boats arose as an insurance issue. Gallagher has confirmed that it's not essential for non-members who race to be made temporary members, but to do so widens the insurance cover to include a member-to-member extension on the policy. A clause will therefore be added to entry forms stating that non-members will be made temporary members for the duration of the race in which they are entered, which Gallagher has advised is sufficient.

Reciprocal Clubs. Guy Ashton visited [Real Club Maritim Barcelona](#) in August and subsequently emailed the Commodore to recommend it for reciprocity. The Vice Commodore's Committee looked at Reial Club Maritim Barcelona, but identified an older, more established and traditional club in Barcelona - [Real Club Náutico de Barcelona](#) (RCNB). The VC approached the latter regarding reciprocity and, following a meeting of their board of directors, they confirmed that they were keen to enter a reciprocal agreement. They have submitted an agreement, which is more formal than what we are used to, so the VC proposes to negotiate this into a less formal Memorandum of Understanding if possible. [All present agreed in principle to a reciprocal agreement with Real Club Náutico de Barcelona but would also like to follow up on reciprocity with Reial Club Maritim Barcelona due to the invitation apparently made to Guy Ashton by its Commodore and its ties with the America's Cup, which it hosted last year.](#)
