**11/25 Apologies** As above

**12/25 Approval of the Minutes of 24<sup>th</sup> January 2025:** The minutes were approved as a true record.

**13/25 Matters Arising**

Corporate Membership. VC updated the VCC on feedback from GC. The GC considered corporate Membership but felt that the Club would find it difficult to manage corporate members, e.g. maintain our ethos, vetting, additional numbers, subscriptions, voting rights, etc. Additionally, this topic had been raised approximately 10 years ago. The GC decided that the Club should not agree to Corporate Membership. VC thanked PC for the work he put into his paper which will be kept on file and referred to should the topic be raised in future.

**14/25 Bank House**

VC informed the VCC that the Commodore reported at the last GC that Bank House has been sold and that the Club has acquired the grass strip of land from the old Boatman's workshop and round to 1.5m east of the Holm Oak as one enters the Club's drive, i.e. almost all of the land currently used by the Club. VC said that the new owners, Mr & Mrs Greening, will install a fence running perpendicular to the existent fence forming the boundary between Club land and the Bank House Garden, and then west to the front of the Club's drive entrance to secure their land. DP asked whether Mr & Mrs Greening would repair that part of the fence that had collapsed and is now being propped up. VC confirmed that the fence belongs to Bank House that they would be repairing it. VC also said that Mr & Mrs Greening have been provided with complimentary Membership of the Club for 3 years. The Commodore and RCH will be meeting Mr & Mrs Greening on 22<sup>nd</sup> February.

**15/25 Vice Commodore's Points**

**Maintenance Projects:** the maintenance projects carried out by Duncan Waite (DW) have been completed. DW was able to save a good deal of VAT on materials. He also carried out additional works, that he found as he completed the projects, at no additional cost. There are some more works required for which DW will be providing a quotation. Whether these works are completed this year will depend on whether GC considers them to be mandatory or discretionary, and the costs. We need to manage our budget very carefully this year.

**Solar Panels:** VC said that GC agreed that the Club should be pursuing a green agenda, however, we need to manage costs carefully. GC would like to review the financial position at the end of Q1 before deciding whether to progress the solar panel project.
